INNOTHON & APPATHON

TERMS AND CONDITIONS

- 1. Organizer: TATA Power Delhi Distribution Limited is the organizer of innothon and appathon.
- **2.** Co-organizer: India Smart Grid Forum (ISGF) and Netaji Subhas Institute of Technology (NSIT) are the co-organizers.
- 3. Sponsors: TATA POWER-DDL and ISGF are Sponsors.
- **4.** Innothon & Appathon is void where prohibited by law. By participating, the participants agree to these terms and conditions.
- **5.** Innothon & Appathon begins at 4 pm on 11th March 2016 and ends at 6 pm on 13th March 2016.
- **6.** Participation in Innothon & Appathon constitutes Participant's full and unconditional agreement to and acceptance of these Terms and Conditions ("Terms"). The term "The participants" refers to you, the "Participant".
- 7. The employees of the organizers and partners (ISGF, TPDDL, NSIT and pManifold) are not eligible to participate.
- **8.** The participants can participate either as part of a team of maximum four (4) people or on an individual basis. Switching teams is not allowed. Organisers and Co Organisers are not responsible for, and will not assist in resolving, any disputes between team members.
- **9.** To participate, participants must be present at Netaji Subhas Institute of Technology, Dwarka, Delhi.
- **10.** The participants must make their own travel and accommodation arrangements and cover all associated costs and expenses.
- **11.** A team may only submit one Entry. Individual Participants may only submit one Entry. Incomplete Entries may be disqualified.
- **12.** Organizers and Co-Organizers reserve the right to merge / cancel the events at any point of time. In such case, registration fees will be refunded.
- **13.** Scoring of Entries: A panel of 4 or 5 people with relevant expertise will be responsible for judging entries.

The Entries will be judged according to the following criteria:

- (i) Originality/creativity (20%);
- (ii) Innovation (25%);
- (iii) Analytical skills (10%);
- (iv) Strategic thinking (15%)
- (v) Practical implementation (30%).

The Entry that earns the highest overall score will win. The decisions of the judges will be final. In the event of a tie, judges will deliberate to determine the winner.

Each Participant or team must be available during the judging period to demonstrate the Participant's or team's Entry. Judging will be conducted in a "science fair" format, so judges may inspect Entries at any time during the judging period. Participants whose

Entries are awarded the top 8 scores by the judges will also be asked to demonstrate their model at India Smart Grid Week 2016 and winner will be announced on 17th March at Le Méridien, Janpath, New Delhi.

The judging period may be extended by Organisers and Co - Organisers for any length of time, in Organisers and Co - Organizers' discretion. If a judge or Participant identifies to Organisers and Co - Organisers a conflict of interest, that judge will be recused from judging the Entry with the conflict and an alternate judge will be identified as a substitution for the judge with the conflict.

Each Entry must be original, of the Participant's or Participant's teams own creation and newly written during the Innothon & Appathon and must not have been entered in any other competition or program similar to the Innothon & Appathon, including other competitions conducted by Organisers and Co - Organisers.

Entries may be subject to a due diligence review at any time for eligibility and compliance with these Terms. Determination of eligibility and compliance is at the sole discretion of Organisers and Co - Organisers. Organisers and Co - Organisers reserve the right to disqualify any Entry if the Entry or a Participant or a Participant's team does not comply with these Terms.

Ownership of Entries: Participant represents and warrants that the Entry is and will be Participant's own original work and does not and will not infringe the intellectual property or proprietary rights of any third party, including, without limitation, any third party patents, copyrights or trademarks. Participant hereby agrees not to instigate, support, maintain or authorize any action, claim or lawsuit against the Organizers and Co – Organizers or the Sponsors, or any other person, on the grounds that any use of a Participant's Entry, infringes any of Participant's rights as creator of the Entry, including, without limitation, trademark rights, copyrights and other intellectual property rights.

Participants hereby agree that the Organizer (which is TATA POWER-DDL) shall have the first right towards the work developed by the Participants for the further development or for reproduction or for commercialization at a larger scale.

Each Participant acknowledges and agrees that Organisers and Co - Organisers or other Participants or third parties may have developed or commissioned works which are similar to the Entry of Participant or Participant's team, or may develop something similar in the future, and each Participant waives any claims that Participant may have resulting from any similarities to the Entry of Participant or Participant's team.

Prizes: The winner will be awarded a prize worth 1 lac rupees. The 1st runner up will receive a prize worth 60,000 rupees. The second runner up will win a prize of 40,000 rupees. 5 Consolation prizes will be awarded worth 10,000 rupees.

Publicity: Except where prohibited, by participating in the Innothon & Appathon, Participant consents to the use of his/her name, photo and/or likeness, biographical information, entry and statements attributed to Participant (if true) for advertising and promotional purposes, including without limitation, inclusion in Organisers and Co - Organizers newsletters, Organizers and Co - Organizers and any of the Organisers and Co - Organizers social media accounts or outlets without additional compensation.

Indemnity: The participants agree to release, indemnify, defend and hold Organisers and Co-Organisers and their parents, affiliates, subsidiaries, directors, officers, employees, Organisers and Co-Organisers and agents, including advertising and promotion agencies, and assigns, and any other organizations related to the Innothon & Appathon, harmless, from any and all claims, injuries, damages, expenses or losses to person or property and/or liabilities of any nature that in any way arise from participation in the Innothon & Appathon or acceptance or use of a prize or parts thereof, including without limitation
