Special Conditions Of Contract

Amendment- 1

- 1) RO amended for Material Code change only.
- 2) Rest all T(>&<)>C shall remain same as per original.

Original RO T(>&<)>C -

- 1) Delivery of material:

Being First LOT in RC i.e. 5000 no., meters shall be delivered in 4 months from CAT-A / manufacturing clearance receipt by BA.

- 2) Guarantee Period - 66 months from the date of supply in respective RO. Latent defect shall be covered in main guarantee period.

- 3) Meter S. No. shall be approved from Tata Power DDL before mass manufacturing.

- 4) Duplication of meter S. No / Mismatch of S. No. between main & individual cartons will be penalized suitably as per TPDDL's discretion.

- 5) The analysis of defective smart meter within Guarantee period shall be provided by meter OEM#s to MMG Dept. OEM shall ensure to establish a system where they will visit MMG premises, in every 15 days or on accumulation of 250 defective meter (whichever comes first) and provide the detailed analysis report of faulty meters i.e. the fault due to quality issue of meter or any other reason.

- 6) OEM shall ensure compliance of SLA of defective smart meter replacement within Guarantee Period i.e. OEM shall lift defective meters within 15 days of intimation from MMG, TPDDL and will return within 30 days after lifting the meter from TPDDL.

- 7) Payment Terms - Shall be released within 30 days of material acceptance at Store.

- 8) All other T(>&<)>C shall be applicable as per RC 4600004955.
