How many times can I avail the offer?

A customer can avail the cashback offer once every month for a period of 3 months for example refer below table..

1. If Consumer make TPDDL bill payment First time in the month of July for Rs.100 or more S/he is also eligible for cashback in the months of August & September too if S/he make payments for said months for Rs.100 or more in each month.
2. If Consumer make TPDDL bill payment First time in the month of August for Rs.100 or more S/he is eligible for cashback for the month of Sept also if S/he make payments in Sept for Rs.100 or more but in this case no cashback will be applicable for the month of July'20 as no payment made in the said month.
3. If Consumer make TPDDL bill payment First time in the month of September for Rs.100 or more s/he is eligible for cashback only for the month of Sept and in this case no cashback will be applicable for the months of July & August'20 as no payments done in the said months.

When will I receive my Cashback?

You will receive your cashback within 3 days of completing your payment every month.
