Sir,

With reference to your email dated 2/05/2022 forwarding the Hon'ble APTEL's Order dated 29/04/2022 in IA No. 614 of 2022 in Appeal No. 334 of 2021, it is observed that Hon'ble APTEL has modified the stay in Order dated 29/09/2021 and Tariff Order dated 30/09/2021 and has limited the stay to only 2 specific issues namely Service Tax and AT&C Losses.

- 2) Further, with respect to your request, stipulated in email dated 2/05/2022 and letter dated 6/04/2022, for extension of 8.50% PPAC w.e.f. 1/04/022, I am hereby directed to convey that the Commission in accordance with Regulation 172 of DERC (*Terms and Conditions for Determination of Tariff*) Regulations, 2017 and Regulation 37 of DERC (*Business Plan*) Regulations, 2019 allows recovery of additional burden by continuing 8.50% PPAC, on provisional basis, as approved in the DERC letter dated 9/04/2021, from 1st April 2022 till 30/09/2022. The surplus created if any, will reduce the burden of Carrying Cost to end consumer and allows liquidation of Regulatory Asset over and above that liquated through levy of 8% Surcharge.
- 3) The said PPAC is to be levied over and above PPAC, if any, applicable for various quarters of FY 2022-23 which may be levied as per provisions of DERC (*Business Plan*) Regulations, 2019 without going through the Regulatory proceedings.

This issues with the approval of the Commission.
