Sir,

This has reference to the above cited letters received from BRPL, BYPL and TPDDL and various Petitions filed by the DISCOMs before the Commission for seeking approval for levy of differential PPAC.

In this regard, I am hereby, directed to convey that, in order to reduce the burden of carrying cost to end consumer and creation of Regulatory Asset, PPAC % approved by the Commission vide its Order dated 13/11/2020 (i.e. 7.94% for BRPL, 7.43% for BYPL and 8.50% for TPDDL) may be continued from the date of issuance of this letter till 31/03/2022 by all DISCOMs. It will enable recovery of withheld differential PPAC filed through Petitions before the Commission, recovery of expected Arrears filed through Petitions by various GENCOs (NTPC, NHPC, DVC etc.) before CERC for True-up of FY 2014-15 to FY 2018-19 and liquidation of regulatory asset, on account of surplus created if any, in lieu of 8% Regulatory Asset Surcharge. The said PPAC to be levied over and above PPAC, if any, applicable for various quarters of FY 2021-22 which may be levied as per provisions of DERC Business Plan Regulations, 2019 without going through the regulatory proceedings.

This issues with the approval of the Commission.
