This has reference to the above cited Order of CERC wherein they have rejected the petition filed by TPDDL for relaxation of Payment Timelines with respect to the payments to be made to the GENCOs and PGCIL against the arrear bills as issued by CERC in its relevant Orders. This has further reference to the above cited letters received from BRPL, BYPL and TPDDL wherein they have requested for charging past period due of PPAC for FY 2019-20.

- 2. In this regard, I am hereby directed to convey that in order to avoid the burden of carrying cost to the end consumers, the Commission has decided that BRPL, BYPL and TPDDL shall continue to levy the PPAC charged by them in the month of July 2020 (BRPL 7.94%, BYPL-7.43% and TPDDL 7.14%) from date of this letter till the issuance of Tariff Order for FY 2020-21 or till further Orders of the Commission as per provisions of Tariff Regulations, 2017 and Business Plan Regulations, 2019. It is further clarified that the said PPAC shall be over and above the PPAC being self-levied by DISCOMs (BRPL 0.15%, BYPL-1.62% and TPDDL 1.92%) against the Power Purchase of Quarter1 of FY 2020-21.
- 3. This issues with the approval of the Commission.
