We write with reference to the aforementioned Regulations which mandate the Distribution Licensees to furnish half yearly progress report on Renewable Capacity Addition, generation and purchase of electricity from Renewable Sources in their area. The excerpt of relevant Regulation 4.4 is provided below for ready reference:

“(4) The Licensee(s) shall submit half yearly progress report to the Commission, on the capacity addition, generation and purchase of electricity from renewable energy sources in their area(s) of supply, which is used by generator itself or sold to third party under open access, and also post them on their website.”


The Renewable Energy Capacity addition in H1 FY 2020-21 has been 2.5 MW.
