We write with reference to the aforementioned Regulations which mandate the Distribution Licensees to furnish Quarterly progress report along with RPO compliance status of Open Access Consumers & Captive Users on Renewable Capacity Addition, generation and purchase of electricity from Renewable Sources & purchase of RECs. “5(5) The Distribution Licensee shall submit its quarterly progress report to the Commission along with RPO compliance status of Open Access Consumers & Captive Users on the capacity addition, generation and purchase of electricity from Renewable Energy Sources & purchase of RECs and also upload the progress report on its website.”
